

Stanley Park will open for passive recreation only, with consideration for State and Local Social Distancing guidelines.

1. The Stanley Park entrances (Gate 1) Western Ave entrance by the Athletic Fields & across from the Woodward Center, (Gate 2) main Western Ave entrance, (Gate 3) on Kensington Ave. and the Granville Rd. entrance (Gate 5) will be open for parking from 8:00am until dusk, weather permitting. Upon entrance, please note gate closing times.
2. Parking will be limited to the parking lots and marked parking spots. Please do not park on the grass or along the roadways. Handicap parking spaces are available.
 - a. There are limited Partner in Preservation parking spaces reserved for Stanley Park members. These spaces are available to members on a first-come, first-served basis.

Please be considerate of Park Rangers who need to monitor parking and entrances.

3. Per order of the Commonwealth of Massachusetts (Section 2 of COVID-19 Order No.55) **All persons over the age of 5 must wear masks or cloth face coverings over their mouth & nose while visiting Stanley Park.**
4. Any groups (family, etc.) within the Park are limited to 10 or less, need to practice Social Distancing and wear masks.
5. The basketball courts and athletic fields for group athletics remain closed at this time.
6. The playground, play-structures, and picnic area are open at this time. Please maintain social distancing when using these areas, and wear a mask when social distancing is not possible. Please do not move picnic tables in the picnic area.
7. The tennis courts will be open from 8:30am – 5:00pm in 1 hour increments (unless no one is waiting).
 - a. Users should sanitize hands before & after play, not share equipment & wipe down all equipment after use.
 - b. Players must sign up on schedule sign located on the outside fence of the tennis courts.
 - c. Users waiting to utilize a court must wait outside the court's fence until previous users have vacated the courts.
 - d. Please mark the tennis balls that your group is using.
8. There is limited restroom availability.
9. Stanley Park Main Office and Development Office will be closed to the public, but staff are available between 8:00am – 4:00pm, Monday through Friday, by phone 413-568-9312 or email. If you need to conduct in-person business with the offices, please call and we will direct you through our social distancing procedures.
 - a. In the event of an emergency while the Park is open, the Park Ranger direct line is: (413) 297-9456.
10. We ask all Park visitors to be thoughtful and mindful of others while visiting Stanley Park and use all precautions by following "Social Distancing" guidelines.
